Happy New Year! Big news that I'm sure you all have already heard: In December the U.S. Congress voted to raise the national minimum age to purchase tobacco (and vape products) to 21. What does this mean for us in Sublette County, where the state law to purchase tobacco products is still 18? The next Tobacco Task Force meeting is Monday January 6 at 12 noon, BOCES. We will be exploring the changing legal landscape, celebrating accomplishments, and sending thank you cards to local and federal lawmakers for their efforts. We want to thank the Marbleton Town Council for thoughtfully and carefully considering a town ordinance banning the sale of flavored vapes. Council will be doing a second reading on that ordinance this coming Monday at their monthly meeting, with time for public input. Council has also set aside time at the beginning of the meeting to learn about how the federal law will be enforced in the immediate future. That meeting begins at 5 pm at Town Hall in Marbleton.
