- Chair proposed changing name of coalition from Sublette County Prevention Coalition to Sublette Prevention Coalition on recommendation of website developer who advised name change for more effective search engine. Discussion followed. Lori Joyner disagreed with name change stating that the word "County" identifies the coalition with a state and government entity. Stephanie Lund stated that the coalition is not in fact a government entity but an advisory board to the county prevention grant managers. Lori was OK with that distinction and vote to change name to Sublette Prevention Coalition followed.

12:25 - 12:35: Matthew Daniels: Co-chair of Suicide Prevention Task Force reported on monthly meeting: 12 Sublette people now certified to train QPR Gatekeepers and are developing a Sublette specific power point to accompany the QPR mandated power point. Expect to train 200-300 Gatekeepers by June 2020. Next community mental health training set for May 2020, curriculum TBD by task force by November 30, 2019. September is Sublette Suicide Awareness Month. SPC will hold candlelight vigil walks in Big Piney and Pinedale in support of those who have lost loved ones to suicide, followed by ecumenical services in local parks. Also will hold movie nights on both sides of the county to increase awareness, "Suicide - The Ripple Effect", and "The 'S' Word" both recommended by task force members.
